**1. NAME**

The name of this corporation shall be:

**2. PRINCIPAL OFFICE**

**3.. PURPOSE**

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Florida Nonprofit Public Benefit Corporation Law for charitable purposes. The corporation is organized and operated exclusively for charitable, religious, educational, and/or scientific purposes under section 501 (c) (3) of the Internal Revenue Code.

The corporation is organized is to provide affordable housing to financially disadvantaged families in Martin County Florida, and any other location within, or without, the state of Florida, and to conduct any other activity permitted under F.S. Chapter 617. and IRC Section 501(c)(3).


**8. DISSOLUTION**
