Articles of Incorporation
for

WE, the undersigned, with other persons, a majority of whom are citizens of the United States, being desirous of forming a corporation not for profit under the provisions of Chapter 617.0202, of the Florida Statutes, do agree to the following:

ARTICLE I – NAME

The name of this corporation is: **Daniels Sword Ministries Inc.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

2246 Wiley Street, Hollywood, Florida 33020

ARTICLE III – PURPOSE

SECTION 1. **Daniels Sword Ministries, Inc.** is organized and operated exclusively for religious, education, and charitable purposes, and not for monetary, profit, for providing, establishing, maintaining, and operating Daniels Sword Ministries, Inc. for the care and treatment of persons needing religious and spiritual attention by renewing the faith of individual persons in our Lord Jesus Christ.

SECTION 2. The general purpose for which the **Daniels Sword Ministries, Inc.** is organized is to do all and everything necessary and proper and lawful for the accomplishment of its specific and primary purpose (which may include the transaction of any and all lawful business for which corporations not for profit may be incorporated under Florida Statutes and under Section 501(c)(3) of the Internal Revenue code of 1954 or corresponding provisions of any subsequent federal tax laws).

SECTION 3. The **Daniels Sword Ministries, Inc.** is authorized to accept, hold, administer, invest, and disburse for religious, educational, and charitable purposes only, such funds as may be given to it by person, persons, or corporations, or earned by it in its activities, to receive and keep gifts and make financial and other type contribution and assistance to other religious, educational, and charitable organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future Unites States Internal Revenue Law.

ARTICLE 1V – MANNER OF ELECTION

The members of the Board of Directors shall be elected unanimously by the current members of the Board of Directors of the **Daniels Sword Ministries, Inc.** under the provisions of the By-laws and shall hold office in accordance with the By-laws.

The Board of Directors shall be responsible for the management and control of the Daniels Sword Ministries, Inc. The **Daniels Sword Ministries, Inc.** shall have five directors initially. The number of directors may be increased or decreased pursuant to the By-laws.

ARTICLE V – INITIAL DIRECTORS/OFFICERS

The names and residence addresses of the persons who are to serve as directors and officers for the ensuing term, or until the Board of Directors of the Daniels Sword Ministries, Inc. elects new officers are:
