ARTICLE I NAME

ARTICLE II PRINCIPAL OFFICE

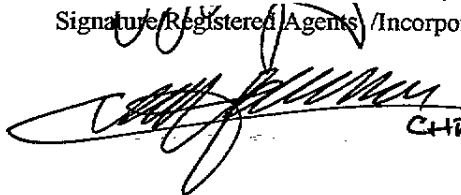
