ARTICLE I **NAME**

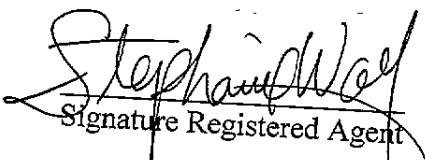

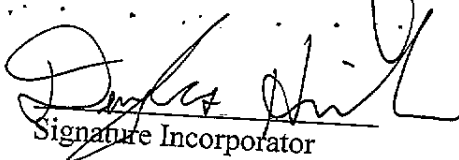
