## Articles of Incorporation For Corner Stone Ministries of South Dade, Inc.

We, the undersigned incorporators, do hereby make, subscribe, acknowledge and file with the Secretary of State of Florida under the Florida Statutes, Chapter 617, these Articles of Incorporation for the purpose of forming a corporation, not for profit, under the laws of the State of Florida.

#### Article I

The name of the church is Corner Stone Ministries of South Dade, Inc.

#### Article II

The principle place of business is 1350 SW 4th Street, Homestead, Florida, 33030.

The mailing address is 1224 NW 8th Court Florida City, FL 33034

#### Article III

Corner Stone Ministries of South Dade, Inc. is a church, and is organized accordingly. The specific purpose for which this church is organized is to provide a place of worship, reflection and spiritual renewal to the residents of the Homestead/Florida City area. Corner Stone Ministries of South Dade, Inc. will also provide services to those in need in the community, including but not limited to, a food pantry, counseling services, and educational enrichment opportunities. All of these services will be free to the persons receiving the service.

Corner Stone Ministries of South Dade, Inc. is organized exclusively for charitable purposes, and it will operate exclusively under the guidelines of 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of Corner Stone Ministries of South Dade, Inc. shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that Corner Stone Ministries of South Dade, Inc. will be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3).

No part of the activities of Corner Stone Ministries of South Dade, Inc. will be the carrying on of propaganda, or otherwise attempting to influence legislation, and Corner Stone Ministries of South Dade, Inc. shall not participate in, or intervene in, (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provision of these articles, Corner Stone Ministries of South Dade, Inc. shall not carry on any other activities not permitted to be carried on (a) by a church exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, (or corresponding section of any future Federal tax code) or (b) by a

church contributions to which are deductible under Section 170(c)(2) of the Internal Revenue code (or corresponding section of any future Federal tax code.)

#### Article IV

The manner in which the directors are elected is stated in the bylaws.

Upon dissolution of the church, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding sections of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the church is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for purposes specified in section 501(c)(3) of the Internal Revenue Code.

#### Article XI

The church reserves the right to amend or repeal any provisions contained in these Articles of Incorporation in accordance with the Florida Statutes.
