ARTICLES OF INCORPORATION

OF

We, the undersigned with other persons, are desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I
(Name)

The name of this corporation shall be "WALTER JONES, American Legion Post 244 of Jacksonville, Incorporated."

ARTICLE II
(Address)

ARTICLE III
(Purposes)

The general purposes of this corporation are exclusively charitable, scientific, literary and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954, or the corresponding of any future United States Internal Revenue Law(s).

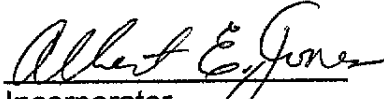
