#### ARTICLES OF INCORPORATION

The undersigned subscriber to these Amended Articles of Incorporation, a natural person competent to contract, hereby files for record the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of the corporation shall be:

#### S.A.F.E. SOCIETY OF FLORIDA, INC.

#### ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

#### ARTICLE III. PURPOSE

The purpose for which this corporation is organized is to exclusively promote the rescue of homeless, unwanted and/or abused pets and to provide foster homes for the homeless, unwanted and/or abused pets. Further, the purpose of the corporation is to educate the community in the furtherance of the corporation's charitable mission.

#### ARTICLE IV. DISSOLUTION

Upon dissolution of the corporation, all of its assets, tangible and intangible, shall be dedicated to an organization selected by the Board of Directors to be used in such a manner as will accomplish the general purposes for which the corporation was organized, provided, however, that distribution be made to a non-governmental organization exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code.

Under no circumstances shall any of the assets of the corporation, upon



dissolution, be distributed to any member hereof.

#### ARTICLE V. DIRECTORS/MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The property, affairs, business and operation of the Corporation are to be managed by a Board of Directors, subject and subordinate to the authority of the member of the Corporation to the extent set forth in these Articles of Incorporation and in the bylaws of the Corporation. The number of directors may be increased or diminished from time to time, but shall never be an even number of directors, or less than three (3) members. The directors shall be divided into three (3) classes with staggered terms. \*The Board of Directors shall consist of business owners and/or members of the community that the corporation\*\* serves. The method and selection of the Board of Directors shall be set forth in the By-Laws.
