We the undersigned officers of **MINISTERIO CRISTIANO DE APOYO ESPIRITUAL, INC.** in accordance with the laws of the State of Florida do submit this charter for incorporation as a corporation not for profit under the provisions of Chapter 617.013, Florida Statutes:

ARTICLE I

The name of this corporation shall be:

MINISTERIO CRISTIANO DE APOYO ESPIRITUAL, INC.

ARTICLE II

The initial street address of the principal office of this corporation in the State of Florida is:

2388 West 66 Place, Hialeah, Florida 33016

The Board of Directors, may, from time to time, move the principal office to any other address in Florida. Branch offices may be maintained at such other places in the State of Florida, the United States of America and foreign countries as may, from time to time, be authorized by the Board of Directors.

ARTICLE III

The specific purposes for which the corporation is organized are:

- To conduct religious worships and educational programs related to churches, schools, parsonages and other institutions connected therewith of a religious, educational, charitable and benevolent character to the end that its own members and others may be generally instructed and guided concerning those articles of faith most surely held among Christian Churches, and to promote home and foreign missions, and to aid in the spreading of the Gospel of Jesus Christ.
- All revenue, profit, income and money received by the Corporation shall be used and employed in religious, charitable, educational, benevolent and missionary work, and never for the benefit of any member of the Corporation individually or collectively.

ARTICLE IV

Qualification of Members:

- Any person who has made a public profession of faith in Jesus Christ and has been baptized in this church or a church of like doctrine may become a member upon receiving a majority vote of the Board of directors present.

ARTICLE V

Manner of Admission:

- An individual who presented himself for membership upon public profession of faith in Jesus Christ as Savior and Lord with the expressed desire for baptism shall become a Member.
- An individual who presented himself/herself for membership upon promise of a letter of recommendation from another Christian church or like doctrine shall become a member upon receipt of such letter.
- An individual who presented himself/herself for membership by statement of prior conversion experience and baptism in a church of like doctrine when no letter is obtainable shall become a member immediately.

ARTICLE VI

This corporation shall have perpetual existence.

ARTICLE VII

The names of the subscribers to this document as well as their addresses as required by Chapter 617.013 Laws of the State of Florida are:

ARTICLE VIII

The officers of the corporation shall be the President/Secretary, and the Vice-President. All officers are designated and elected by a majority vote of the Board of Directors at its annual meeting. The elections of the directors is as stated in the by-laws

ARTICLE IX

The bylaws of the corporation, sometimes called policies, may be made, altered, amended or rescinded by the Board of Directors at its annual meeting, provided that proper notices has been given at a previous regular business meeting and a copy of the proposal be furnished in writing to each member present; and provided further that once adopted any change must received the affirmative vote of two-thirds of the members present and voting.

ARTICLE X

Amendments to the articles of incorporation (this Charter) may be proposed by any member of the Board of Directors, or a petition in writing signed by any five individual members. Any amendment so proposed may be adopted by a two-thirds affirmative vote of those present at any regular business meeting, provided notice of intent to amend has been included in the church bulletin and announced at regular worship services on the Sunday prior to said meeting. Election of the Board of Directors is as stated in the by-laws.

ARTICLE XI

This corporation is to have the powers to do any and all things necessary or expedient for carrying out the objects and purposes of said corporation, and in general to possess all rights, privileges and immunities, and enjoy all the benefits granted to corporations of similar character under the laws of the State of Florida.

The corporation shall adopt a seal which shall contain the words "**MINISTERIO CRISTIANO DE APOYO ESPIRITUAL, INC.**" and the words "**Corporation not for Profit**"
