ARTICLES OF INCORPORATION

OF

THE OAK RUN VETERANS ASSOCIATION, INC.
(A CORPORATION NOT FOR PROFIT)

We, the undersigned, desiring to form a corporation not for profit under the laws of the State of Florida for the purpose hereinafter expressed, do hereby make, subscribe and acknowledge the Articles and agree to the following.

ARTICLE I

Name

This corporation shall be known as THE OAK RUN VETERANS ASSOCIATION, INC.

ARTICLE II

Principal Office

The principal place of business and mailing address shall be:
10881 SW 89th Avenue Ocala, Florida 34481

ARTICLE III

Objectives and Purpose

The general nature of the objectives and purpose of this corporation shall be to foster patriotism, keep alive the memories of the veterans, and to organize the social and cultural activities desired by the members within this organization.

ARTICLE IV

Elections

Elections shall be held annually at the October meeting for all officers/directors of the corporation and shall be elected, by a majority vote, of the members present and entitled to vote. The term shall be for one year. In the event of a vacancy occurring, the remaining officers/directors may appoint a member to fill the remainder of the term of the vacated office.

ARTICLE V

Board of Directors

The Board of Directors shall manage the general business of the corporation. This corporation shall have three (3) directors initially. The number of directors may be increased or decreased from time to time as the by-laws may specify but may never be less than three (3) or more than seven (7).
