ARTICLES OF INCORPORATION OF

NEW MOUNT PLEASANT MISSIONARY BAPTIST CHURCH INC. A CORPORATION NOT-FOR-PROFIT

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be: NEW MOUNT PLEASANT MISSIONARY BAPTIST CHURCH INC., (hereinafter referred to as the "Ministry").

ARTICLE II. PURPOSE

The purpose and object of the Ministry shall be to teach and spread the gospel of Jesus Christ, to utilize biblically based methodology in broadcasting, research, counseling and professional approaches to healing and ministering to the body, mind, and spirit. The Ministry shall also conduct any and all business consistent with the laws of the State of Florida and United States of America.
