ARTICLES OF INCORPORATION

OZMA 12 M. C. 15

In Compliance with Chapter 617, F.S. (Not-For-Profit)

The undersigned incorporator, for the purpose of forming a corporation not-for-profit under Chapter 617, Florida Statutes, as amended, hereby adopts these Articles of Incorporation:

ARTICLE I - NAME

The name of the Corporation is: EVERGLADES HISTORIC CAMP OWNERS ASSOCIATION, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be: 2900 East Oakland Park Blvd., Fort Lauderdale, Florida, 33306.

ARTICLE III - PURPOSE

The purpose for which the Corporation is organized is:

To provide an organized and effectively managed organization which will promote, preserve and protect the common interests and investments of those persons who own and use habitable structures located in the Everglades.
