ARTICLES OF INCORPORATION

OF

VICTORIOUS CHRISTIAN LIFE MINISTRIES, INC.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation in compliance with Chapter 617, Florida State Not for Profit:

I.

The name of the corporation is "VICTORIOUS CHRISTIAN LIFE MINISTRIES, INC."

II.

The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

III.

The purposes for which VICTORIOUS CHRISTIAN LIFE MINISTRIES, INC., is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Law.

IV.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 © (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

V.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

VII.

The corporation will not have members.

VIII.

Board of Directors: Election of new directors or election of current directors to a second term will occur as the first item of business at the annual meeting of the corporation. Directors will be elected by a majority vote of the current directors. A director's membership, with exception of the President/CEO can be dissolved without cause. President/CEO can be dissolved through resignation only.

IX.

The mailing address of the initial registered office of the corporation is 1543 Sabra Drive, Brooksville, Hernando County, Florida, 34601, and the initial registered agent of the corporation at such address is Tommy Mason.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
