ARTICLES OF INCORPORATION
OF
ENVIRONMENTAL POLLUTION REGISTRY, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a nonprofit corporation under the provisions of Chapter 617, laws of the State of Florida .

ARTICLE I -- NAME

This corporation shall be known as ENVIRONMENTAL POLLUTION REGISTRY, INC. hereafter referred to as REGISTRY, and shall have its principal office at 6287 Bahia Del Mar Cir., #1201, St. Petersburg, FL 33715.

ARTICLE II -- PURPOSE AND OBJECTIVES

The purposes for which REGISTRY is formed are:

- (1) To conduct, coordinate and direct education of the general public in matters related to the environment and law.
- (2) To conduct, coordinate and direct education related to the applications of, and expressions of, the improvement of the environment.
- (3) To conduct research and to resolve pollution problems associated with environmental pollution in the United States of America.
- (4) To initiate studies designed to meet the purposes of the REGISTRY.
- (5) Generally to have and exercise all rights and powers conferred on nonprofit corporations under the laws of the State of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property; provided, however, that REGISTRY shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in

furtherance of the primary purpose of REGISTRY.

ARTICLE III -- BYLAWS

The REGISTRY shall establish Bylaws which shall define the rules for the management and regulation of its affairs, and will set forth the qualifications for members and the manner of their admission, and shall set forth the method of election of directors.

ARTICLE IV -- PERIOD OF EXISTENCE

The REGISTRY shall have perpetual existence, until such time, by no less than a three-fourths vote of the Board of Directors, and the consent, in writing, of the President, that REGISTRY shall be dissolved.

ARTICLE V -- FEDERAL TAX-EXEMPT STATUS

(1) The purposes for which REGISTRY is organized are to receive and maintain real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, literary, or educational purposes either directly or by contributions to organizations that qualify as tax exempt organizations under Section 501(c)(3) of the Internal Revenue Code and regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

(2) No part of the net earnings of REGISTRY shall inure to the benefit of, or be distributable to, any Director or Officer of REGISTRY or any member of REGISTRY or any other private individual (except that reasonable compensation may be paid for services rendered to or for REGISTRY affecting one or more of its purposes), and no Director or Officer of REGISTRY, or any private individual shall be entitled to share in the distribution of any of the corporate assets on

dissolution of REGISTRY. No substantial part of the activities of REGISTRY shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and REGISTRY shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

(3) REGISTRY shall conduct its financial affairs and operations so as to remain within the category of a non-private, public charity organization as defined under 501(c)(3) of the Internal Revenue Code, by meeting at least one of the exclusionary tests as set forth in section 509(a) of the Internal Revenue Code.

(4) Notwithstanding any other provision of these Articles of Incorporation, REGISTRY shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code and said Regulations as they now exist or as they may hereafter be amended.

ARTICLE IV -- GENERAL PROHIBITIONS

(1) REGISTRY shall always remain, in its Bylaws and operation, a secular corporation, and shall not function as a religion, shall not adopt a creed, and shall not conduct worship services.

(2) REGISTRY shall not affiliate with, or associate with any religious corporation or group so as to function as an extension of, or auxiliary of, or fall under the control of any religious corporation or group.

(3) Subsections 1 and 2 of this article must not be construed, however, as

prohibiting joint or cooperative scholarly study or research efforts in conjunction with religious corporations or groups relating to their, beliefs, values, mythology, traditions and history insofar as these study or research efforts relate to environmental ethics or other ethics.

(4) Further, Subsections 1 and 2 of this article must not be construed as prohibiting the publication or presentation of a scholarly work which may be interpreted as being in agreement with the views held by a particular religious corporation or group.

(5) Notwithstanding any of the above statements of purposes and powers, REGISTRY shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of REGISTRY. Further, REGISTRY shall not conduct its affairs so as to result in the loss of Tax-Exempt privileges described under Article V of these Articles.

ARTICLE VII -- DISSOLUTION AND DISTRIBUTION

Upon the dissolution of REGISTRY, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of REGISTRY, dispose of all of the assets of REGISTRY exclusively for the purposes of REGISTRY in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the court of the county in which the principal office of REGISTRY is then located, exclusively for such purposes or to such organization or organizations, as

said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VIII - REGISTERED OFFICE AND AGENT

The registered office of the Corporation shall be 3656 First Avenue North, St. Petersburg, FL 33713, and the registered agent at that address shall be RICHARD M. GEORGES.






