### **ARTICLE 111 PURPOSE**

## ARTICLE 1V MANNER OF ELECTION

The Board of Directors will be classified in respect to the time for which they will severally hold office by dividing them into three classes, each class consisting of one-third of the whole number of the Board of Directors. The Directors of the first class will be elected for a term of one year; the Directors of the second class will be elected for a term of two years; and the Directors of the third class will be elected for a term of three years.
