Amendments Adopted

I CAN READ FOUNDATION would like to be considered for 501 (C) (3) status. We are organized and operated exclusively for the purpose to teach reading to children ages three to twelve years old. We do not exclude adults from our program, but our main purpose is early intervention. Our exclusive purpose is to stamp out illiteracy one child at a time.

Our day-to-day activities are as follows: 9:00am – 11:00 we teach pre-school kids phonics and we have story hour. This program is conducted on Monday – Thursday. At this time we have, "Let me read to you". We will read to three or less kids a story while they hold their story pal. This program is conducted on Tuesday and Thursday mornings. On Wednesdays we teach reading to ages five to ten year olds. Monday – Thursdays from 9:00-12:00 are our working hours. We plan a summer program that will run for four weeks that will include, but not limited to pre-school kids to ten year olds. The summer program will include field trips and other planed activities. In our learn to read program all of our services are free. Our purpose is to give kids an early start in reading and the love of books. We are solely dedicated to the 501 (C) (3) purpose as a Non-Profit organization.

NO PART OF THE NET EARNINGS OF THE CORPATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS TRUSTEES, DIRECTORS, OFFICERS OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF SECTION 501 (C) (3) PURPOSES.

NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGALATION AND THE CORPORATION SHALL NOT PARTICIPATEIN OR INTERVENCE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE.

NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A CORPORATION ACCEPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE (OR (B) BY A CORPORATION SECTIONS OF ANY FUTURE FEDERAL TAX CODE) OR (b) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE ORDER.

ARTICLE - OPEN DISSOLUTION OF THIS CORPORATION ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSE WITHIN THE MEANING OF SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, i, e, CHARITABLE, EDUCATIONAL, RELIGIOUS, OR SCIENTIFIC, OR CORRESPONDING DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE.

APPOINTED BOARD MEMBERS

ALL BOARD MEMBERS ARE APPOINTED. THEIR RESPONSIBILITY IS TO CONTRIBUTE TO THE WELL BEING OF THE FOUNDATION AND TAKE AN ACTIVE ROLE IN RISING FUNDS, AND UP HOLD THE GOOD NAME OF, "I CAN READ FOUNDATION" IN THE COMMUNITY. THERE IS NO PRINCIPLE LEADER OF THE BOARD, THEY ARE ALL EQUALS. SWEETY ELAINE DENEGAL IS THE CEO OF THE FOUNDATION, AND THE FOUNDER. IN THE FUTURE THE BOARD PLANS TO APPOINT A PRESIDENT, VICE PRESIDENT, AND SECRETARY. ALL DECISIONS ARE MADE BY VOTING, THE MAJORITY WINS.
