ARTICLES OF INCORPORATION
OF
HUBERT LEOW MINISTRIES INTERNATIONAL, INC.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I
Name

The name of the corporation shall be **Hubert Leow Ministries International, Inc.**

ARTICLE II
Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be: **6334 Pinestead Drive, # 816, Lake Worth, FL 33463.**

ARTICLE III
Purposes

The specific purposes for which the corporation is organized are:

1. To preach and teach the Gospel of our Lord Jesus Christ to all nations.
2. To assemble together for worship, prayer, biblical studies, missionary training in intercessory evangelism, social, educational, and other ministerial activities.
3. To distribute the Word of God, the Holy Bible, as much as possible, free of cost, in underdeveloped countries to pastors, missionaries, lay leaders, and others.

4. To organize, promote, and assist in providing, not-for-profit programs and projects, funds, materials and personnel to construct buildings for churches, schools, homes, health clinics, educational and other ministerial facilities.
5. To organize, promote, and provide programs and projects to feed, clothe, and house the poor, the homeless, and the underprivileged. Also to minister to the needs of seniors, sixty years of age and over.
6. To organize, promote, and provide not-for-profit programs and projects that will offer employment, or occupational training, that people may become gainfully employed and self-supporting.
7. To assist in providing training for ministers of the Gospel of our Lord Jesus Christ, and to assist in supporting pastors, missionaries, and nationals who are serving in full-time Gospel ministry.
8. To own and operate movable and immovable properties, equipment, and assets for the purpose of worship, intercessory prayers, missionary and evangelistic training, schools of learning, and for printing and producing audio-visual materials and programs for mass communication, to successfully fulfill the evangelistic goals and objectives of the ministry.
9. To organize, promote, and provide, as God allows, emergency aid and relief to people in crisis caused by irregular and devastating acts of nature.
10. To work together with other ministries, churches, groups, and individuals, of like faith and beliefs in our Lord Jesus Christ, and for the care and relief of the poor and needy.

11. To negotiate and enter into agreements with financial institutions, funding agencies, corporations, ministries, groups, and individuals, to successfully fulfill the evangelistic goals and objectives of the ministry.
12. To be an intercessory ministry to our affiliated ministries, churches, groups, and prayer partners, and to teach our prayer partners the Biblical principles how, and why, to be an "Intercessor" and a "Soul Winner."

ARTICLE IV


