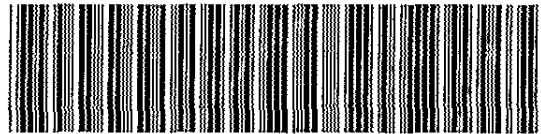

Article II. Purposes:

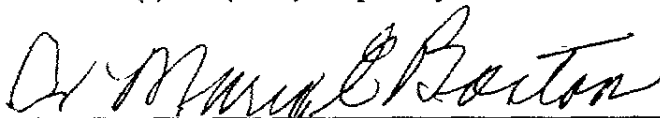
