The undersigned incorporator hereby forms a corporation under Chapter 617 of the laws of the State of Florida.

### ARTICLE I - NAME

The name of this Corporation shall be: GLADES AREA PAL, INC. The address of the principal office of this corporation shall be 224 S.W. 5<sup>th</sup> Street, Belle Glade, Florida 33430 and the mailing address shall be Post Office Box 127, Belle Glade, Florida 33430.

## ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purposes of:

- (a) To foster and encourage the youth of the Glades community with a spirit of loyalty and faith in American traditions and institutions;
- (b) To participate actively in constructive movements and endeavors for the promotion and safeguarding of the interest and general welfare of the youth of the Glades community;
- (c) To promote the spirit of benevolence, friendship, sociability, good will and tolerance among the youth of the Glades community;
- (d) To instill in the youth of the Glades community good healthy habits, good sportsmanship, and high moral and civic standards;
- (e) To perform any and all other things incident and kindred to the above purposes and not inconsistent with law as will further and promote youth programs in the Glades Area of Palm Beach County, Florida;
- (f) To foster and encourage a positive relationship between the youth and law enforcement within our Glades community;

This corporation shall have all powers consistent with and provided by Chapter 617 of the Florida Statutes regarding corporations not for profit.

# ARTICLE III - CAPITAL STOCK

This corporation is organized as a not for profit organization and therefore under a non-stock basis.

## ARTICLE IV - ADDRESS
