Articles of Incorporation  
of  
The Robert's Hollywood Center for Alcoholics, Inc.

**Article I**

The name of the Corporation is The Robert's Hollywood Center for Alcoholics, Inc.

**Article II**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of the State.

**Article III**

The purposes for which the corporations is organized are: exclusively, religious, charitable, scientific, literacy and educational within the meaning of sections 501( c ) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles this Organization shall not carry on any activities not permitted to be carried on by an organization except from Federal Income Tax under section 501 C 3. Of the Internal Revenue Code of 1986 of the corresponding provision of any future United States Internal Revenue law.

The corporation is organized under the Florida Corporations Not for Profit Code for the specific and primary purpose of operating a drug/alcohol rehabilitation center to return the residence to society as productive individuals with high self esteem and function with the ability to without the use of alcohol.

1. To provide a shelter home for the homeless, due the to use of alcohol, and who are recommended by a physician from the rehabilitation centers for treatment of alcohol abuse;
2. To provide opportunities for self improvement
3. To provide a program to the residence in duration of 6 months to one year, with three meals a day, assist with permanent housing, and job replacement

**Article IV**

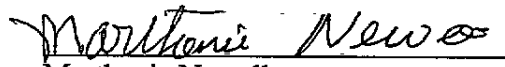

This Corporation reserves the right to amend or repeal many provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of the Board of Directors.

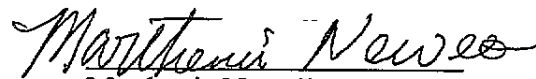

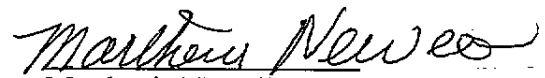
