ARTICLE ONE

Name

The name of the Corporation is Franklin County Medical Society **INC.**

ARTICLE TWO

Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State.

ARTICLE SEVEN






Registered Office and Agent


