The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

IGLESIA ARCA DE SALVACION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are):
To establish and maintain a place for the worship of Almighty God. To provide Christian fellowship for those of like faith where the Holy Spirit may be honored according to our distinctive testimony and propagate the gospel of Jesus Christ. To engage exclusively in religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of the United States of America. This organization is not to operate for the benefit of any individuals, but rather for the public interest and out of a desire to manifest and cultivate faith in our Lord and Savior Jesus Christ.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The executive officers of this organization shall consist of a President, a Secretary, a Treasurer, and such other officers as shall be provided for in the bylaws, which shall be the Trustees of the corporation, all of whom shall constitute and be the Official Board of Directors.

The members of the Official Board of Directors must meet the following additional qualifications:

1. The candidate must believe in and practice the Doctrines and Fundamental Truths of the **Iglesia Arca de Salvacion**

ARTICLE IV MANNER OF ELECTION OF DIRECTORS (continued)

2. The candidate must agree to a) submit to, and b) abide by the Constitutional Bylaws governing members of our church.

They shall be elected from time to time in accordance with the bylaws, and each shall hold office until his successor is elected or appointed and qualified, at its regular annual meeting. The president shall sign and the Secretary shall attest all legal contracts authorized by the members of this corporation and the laws of the State of Florida.

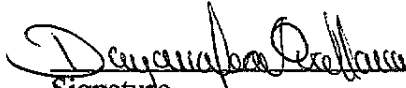
