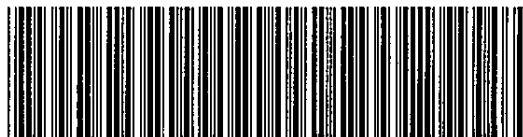

The Corporation having no members entitled to vote on the dissolution of the Corporation or on a plan of distribution of its assets, the following plan of distribution of the assets of the Corporation is submitted to the Board of Directors of the Corporation for adoption or rejection:

1. The only corporate liabilities are the final electric bill and the attorney's fees and costs in connection with the dissolution of the Corporation. These shall be promptly paid in full.
2. The Corporation holds no assets upon condition requiring their return, transfer or conveyance nor holds any assets subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational or similar purposes.
3. The only asset of the Corporation consists of a small checking account at Compass Bank and the balance in that account after paying the above liabilities shall be distributed to Clay Electric Cooperative to provide continuing electric service for the subdivision entrance, for the general health and welfare of the community, consistent with the purpose set forth in the Articles of Incorporation of the Corporation.
