# PHYSICIANS TO SAVE FLORIDA MEDICINE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a not for profit corporation under the laws of the State of Florida.

### ARTICLE I

The name of the not for profit corporation shall be: PHYSICIANS TO SAVE FLORIDA MEDICINE, INC. Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere, as may be authorized by its Board of Directors.

### ARTICLE II

The street address of the initial principal office and mailing address of this corporation shall be: 10139 NW 31st Avenue, Suite 202, Coral Springs, Florida 33067.

# ARTICLE III

The general nature of the business to be transacted by the corporation shall be that provided below:

- (a) To have succession by its corporate name for the period set forth in its articles of incorporation;
- (b) To adopt, use, and alter a common corporate seal, such seal always containing the words "corporation not for profit;"
- (c) To elect or appoint such officers and agents as its affairs shall require and allow them reasonable compensation;
- (d) To adopt, change, amend, and repeal bylaws, not inconsistent with law or its articles of incorporation, for the administration of the affairs of the corporation and the exercise of its corporate powers;
- (e) To increase, by a vote of its members cast as the bylaws may direct, the number of its directors so that the number shall not be less than three but may be any number in excess thereof;

- (f) To make contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage and pledge of all or any of its property, franchises, or income;
- (g) To conduct its affairs, carry on its operations, and have offices and exercise the powers granted by Florida Statutes Chapter 617 in any state, territory, district, or possession of the United States or any foreign country;
- (h) To purchase, take, receive, lease, take by gift, devise, or bequest, or otherwise acquire, own, hold, improve, use, or otherwise deal in and with real or personal property, or any interest therein, wherever situated;
- (i) To make donations for the public welfare or for religious, charitable, scientific, educational, or other similar purposes;
- (j) To have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation is organized;
- (k) To merge with other corporations both for profit and not for profit, domestic and foreign, if the surviving corporation is a corporation not for profit;
- (l) To lobby the federal, state and local governments.
- (m) To engage in any lawful business or activity that will aid governmental policy.
- (n) To make donations for the public welfare or for any charitable, scientific, or educational purpose.
- (o) To do any other acts permissible by, or not inconsistent with, the law.

### ARTICLE IV

The method of election of directors shall be stated in the bylaws of this corporation.
