ARTICLES OF INCORPORATION
OF
THE CHIPOLA PRIMITIVE BAPTIST CHURCH HERITAGE, INC.
A FLORIDA NONPROFIT CORPORATION

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

ARTICLE I

The name of the corporation shall be: **THE CHIPOLA PRIMITIVE BAPTIST CHURCH HERITAGE, INC..**

ARTICLE II

The period of duration of this corporation is perpetually, unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are:

- (a) To restore the Chipola Primitive Baptist Church.
- (b) The general purposes for which this corporation is formed are to operate exclusively for such purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.
- c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate

ARTICLE IV.

The qualifications for members and the manner of their admission shall be as regulated by the bylaws of the corporation.

ARTICLE V.

The street address of the principal office of the corporation is 14963 N.W. J.P. Peacock Road, Altha, Florida 32421, and the name of its initial registered agent as such address is WILLIAM R. PEACOCK.

ARTICLE VI.

The number constituting the initial officers of the Board of Directors of the corporation is three (3), and the names and addresses of the persons who are to serve initially are:

ARTICLE VII.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

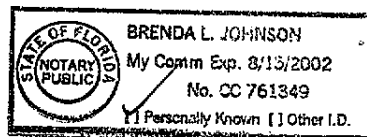
