## **ARTICLE I NAME**

## **ARTICLE III PURPOSE**

The purpose of which the corporation is organized is:

The purpose of Alpha Kappa Alpha Sorority is to cultivate and encourage high scholastic and ethical standards, to promote unity and friendship among college women, to study and help alleviate problems concerning girls and women in order to improve the social stature, to maintain a progressive interest in college life, and to be of service to all mankind.

## **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

- a) The nominating Committee shall be elected by the membership. The Nominating Committee shall convene in October for the purpose of certifying the eligibility of all candidates for office and preparing an official slate of nominees.
- b) The officers shall be elected by secret ballot at the regular November meeting and installed in the December meeting. This shall be the first order of business.
- c) The majority of the all votes cast shall be necessary to constitute an election.
- d) The Anti-Basileus shall be the next Basileus. At the time of her election, she shall possess all the required qualifications of the Basileus.
- e) All officers shall be elected annually for a period of one year, with the exception of the Basileus, and Tamiouchos, which shall be for two years. Any officer shall be eligible to succeed herself once in office.
- f) A member to be a candidate for any office other than Basileus or Anti-Basileus must have been an active member of Alpha Kappa Alpha Sorority for at least two years. She must have chaired at least one committee, attended a Cluster, Regional, or Boule, previously held an office in a chapter of Alpha Kappa Alpha. The Basileus and/or Anti-Basileus must meet the same requirements and must have been an active member for at least three consecutive years preceding her candidacy.
