ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

The undersigned Incorporators, citizens of Florida and of the United States, desiring to form a Not for Profit Corporation under the Not For Profit Corporation Act of the State of Florida, do hereby certify:

ARTICLE I NAME

The name of the corporation shall be:

BAY WIND COMMUNITY BAND, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The Bay Wind Community Band, Inc., is organized to promote the continuing musical education and development of its members to better enable them, individually and as the group, to provide high quality, enjoyable and family-oriented musical performances, as a public service, at various non-political public and charitable events and occasions. The pursuit of this goal shall exclusively be in furtherance of those educational and charitable purposes as enumerated in section 501(c)(3) of the Internal Revenue Code, and the operation of the Bay Wind Community Band, Inc, shall at all times be in compliance with the provisions and limitations of said section 501(c)(3), or the corresponding section of any future federal tax code.

ARTICLE IV MEMBERSHIP The conditions of membership are:

Any musician who plays a band instrument and desires to actively participate shall be entitled to full membership without regard to race, creed, gender, age or national origin.

ARTICLE V MANNER OF ELECTION The manner in which the directors are elected or appointed:

The Board of Directors shall consist of those individuals elected to the offices enumerated in Article V below, and four (4) additional members elected to serve as Directors. The Officers and Directors shall be elected annually by a majority vote of the members of the Bay Wind Community Band who are present at a designated, regularly scheduled meeting/rehearsal. The membership in general shall receive a minimum of fourteen (14) days prior notification that elections will be held at that stated meeting/rehearsal. Oral announcements of the scheduled election at the three immediately prior meetings/rehearsals shall be considered proper notice. The nominations and voting shall be conducted in accordance with Robert's Rules of Order.

Provisions for lengthening and/or staggering the terms of the Directors may be incorporated into the By-Laws.

Article IX LIMITATIONS OF POWERS AND ACTIVITIES The Corporation shall comply with Section 501 (c) (3) as follows:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any

powers that are not in furtherance of the purposes of this corporation.

ARTICLE X DISTRIBUTION OF ASSETS

The Corporation's assets shall be disposed of as follows:

Upon the dissolution of this corporation, assets shall be distributed to one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
