Please consider this letter as our official request to dissolve our corporation "Treasure Coast Cat Club, Inc."

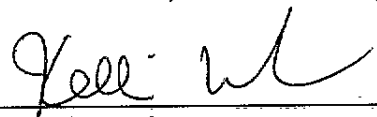
