**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of the Corporation shall be:

**CLUB JOVENES DE LA TERCERA EDAD INC.**

**ARTICLE II - DURATION**

The duration of the Corporation is perpetual.

**ARTICLE III - PURPOSE**

The under signed incorporator(s) for the purpose of forming a not-for-profit corporation under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The purposes of this corporation are:

- A To organize and support activities for persons adult (old 50 years) to enhance quality life.
- B To organize excursions, tours, party, for promote the development of highly qualified individuals and colectivas, how the friendship, solidarity, etc. etc.
- C To exercise all rigths and powers conferred by the laws of the State of Florida upon nonprofit corporations.



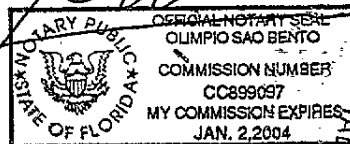
