ARTICLES OF INCORPORATION Of Canon Bible College, Inc.

ARTICLE I CORPORATE NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of this Christian Ministry Teaching, College, Seminary Organization is Canon Bible College, Inc.

ARTICLE II CORPORATE NATURE

This is a nonprofit organization, organized solely for general charitable purposes, of Christian Education and Training; pursuant to the Florida Corporations Not for Profit Law set forth in Section 617 of the Florida Statutes.

ARTICLE III DURATION

The term of existence of the corporation is perpetual.

ARTICLE IV GENERAL AND SPECIFIC PURPOSES

The specific and primary purposes for which this corporation is formed are:

To conduct Seminars, Educational Training Classes, and Courses to assist families and individuals to achieve Christian Training and Educational services, Classes, Courses and College Level Training.

- A. For the advancement of Christian Training and Educational Services, charity, education, and any other related or corresponding charitable purposes by the distribution of its funds for such purposes.
- B. To train members of the Christian Community in their Church and Mission work, and to enhance the Christian Educational Seminars of the various churches that sponsor and Host the Classes and courses of the college.
- C. To operate exclusively in any other manner for such charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.

ARTICLE V MANAGEMENT OF CORPORATE AFFAIRS

A. <u>Board of Directors</u>. The powers of this Christian Ministry Organization shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors, consisting of a minimum of three (3) members of the Board of Directors. The number of Directors of the Christian Ministry Organization shall be three, provided however, that such number maybe changed by a By-Law duly adopted by the members.

The Directors named herein as the first Board of Directors shall hold office until the first meeting of members at which time an election of Directors shall be held.

Directors elected at the first annual meeting, and at times thereafter shall serve for a term of one (1) year until the annual meeting of the members following the election of Directors and until the qualification of the successors in office. Annual meetings shall be held at 5100 West Colonial Drive, Orlando, Florida 32805, On December 1 of each year at 10:00 am, or at such other place or places as the Board of Directors may designate from time to time by resolution.

Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting, if all members of the Board shall individually or collectively consent in a manner to be set forth in the operating by-laws in effect at that time to ratify such action.

Such consent or consents shall be filed with the minutes of the proceedings of the Board, and any such action by consent shall have the same force and effect as if taken by unanimous vote of the Directors.

Any certificate or other document filed under any provision of law which relates to action so taken shall state that the action was taken by unanimous written consent of the Board of Directors without a meeting, and that the Articles of Incorporation and the By-Laws of this Christian Ministry Organization authorize the Directors to so act. Such a statement shall be prima facie evidence of such authority.

C. <u>Corporate Officers</u>. The Board of Directors shall elect the following officers: President, Area Vice Presidents, Secretary, and Treasurer, and such other officers as the By-Laws of this Christian Ministry Organization may authorize the Directors to elect from time to time. Initially, such officers shall be elected at the first annual meeting of the Board of Directors.

ARTICLE VI EARNINGS AND ACTIVITIES OF CORPORATION

- A. No part of the net earnings of the Christian Ministry Organization shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the Christian Ministry Organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.
- B. No substantial part of the activities of the Christian Ministry Organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Christian Ministry Organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
 - B. Notwithstanding any other provision of these articles, the Christian Ministry Organization shall not carry on any other activities not permitted to be carried on
 - C. (a) By a Christian Ministry Organization exempt from Federal income tax under section 501(c)(6) of the Internal Revenue Code of 1954 (or the corresponding provision of any future, United States Internal Revenue Law) or (b) by a Christian Ministry Organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
- D. Notwithstanding any other provision of these Articles, this Christian Ministry Organization shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Christian Ministry Organization.

ARTICLE VII DISTRIBUTION OF ASSETS

Upon dissolution of the Christian Ministry Organization, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the Christian Ministry Organization, dispose of all of the assets of the Christian Ministry Organization exclusively for the purposes of the Christian Ministry Organization in such manner, or to such organization or organizations organized and operated exclusively for charitable, housing and property rights education, Community Professional Business and Trade Training and Educational Seminars, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(6) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Christian Ministry Organization is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VIII **MEMBERSHIP**

The qualification for members and the manner of their admission shall be regulated by the bylaws for this Christian Ministry Organization.
