**ARTICLES OF INCORPORATION

**ARTICLE I  
NAME**

**ARTICLE III  
PURPOSE**

This corporation is designed to keep young kids active in the community. All the kids with disregard to race, creed and gender are with faced with modern day peer pressure. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding

This corporation shall indemnify any officer, director, or incorporator or any former officer, director, or incorporator of this corporation to the fullest extent permitted by the law.

## **ARTICLE X COMPENSATION FOR OFFICERS AND SERVICES PROVIDED**

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its member, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statement) political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## **ARTICLE XI COMMENCEMENT AND DURATION**

This corporation shall commence on the date on which these Articles Of Corporation are filed with Secretary of the State of Florida and shall exist thereafter perpetually until dissolved by law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of an future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not disposed of shall be disposed of by Court Of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## **ARTICLE XII AMENDMENT**

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendments there to, and any right conferred upon the board of directors is subject to this reservation.
