ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION ST. HUGH'S ALUMNAE ASSOCIATION OF SOUTH FLORIDA, INC.

Pursuant to the provision of Chapter 607, Florida Statutes the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: ARTICLE THREE - GENERAL AND SPECIFIC PURPOSES amended as follows:

The Corporation is organized and operated exclusively educational, religious and charitable purposed within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 as amended. Not withstanding any other provision of these Articles, the corporation shall not carry out any other activities not permitted to be carried on (I) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law.)

SECOND: ARTICLE ELEVEN - DISTRIBUTION OF ASSETS is amended as follows:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not such

disposed shall be disposed of by a Court of competent

Jurisdiction of the county in which the principal office of the

corporation is then located, exclusively for such purposes.

THIRD: The amendment was adopted by the Board of Trustees on the 12^{t} day of <u>December</u>, 2006 with the full consent and unanimous approval of the quorum of members entitled to vote.

FOURTH: The amendment was adopted by quorum of members entitled to vote on the 12^{th} day of <u>Jecember</u>, 2006.
