

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the corporation shall be ECONOMIC DEVELOPMENT COUNCIL OF OCALA/MARION COUNTY, INC.

**ARTICLE II  
PRINCIPAL OFFICE**

The principal place of business of this corporation shall be 1515 East Silver Springs Boulevard, Suite 201, Ocala, Florida 34470. The mailing address of this corporation shall be P. O. Box 459, Ocala, Florida 34478.

**ARTICLE III  
PURPOSE**


