ARTICLE I - NAME

The name of this Corporation shall be UNITED CHRISTIAN COUNSELING CENTER, INC.

ARTICLE II - DURATION

The duration of this Corporation is perpetual, unless voluntarily dissolved by the Officers or Directors or according to the Laws of the State of Florida.

ARTICLE III - THE PURPOSE

The general purpose of this Corporation is for counseling and teaching the Word of God, operating a Christian Fellowship Center whereby worship services will be held on the Lord's Day, including Religious weekly meetings, and any other meetings that may be deemed needed or necessary.

To operate for the advancement of Religion by reaching out and reclaiming our families for Jesus Christ, thru counseling, Biblical precepts, Restoring love and respect, Glorifying God by relating his Agape Love to the community and to the world through inter-change.

To organize to keep unity of the spirit in a bond of Love, Peace, Hope and Charity. To function as a Religious and Charitable organization, as will quality it, as an exempt organization under the existing internal revenue code, and any provisions of any subsequent federal tax law, for the purpose of soliciting and distributing charitable gifts to worthy persons or organization.
