DISSOLUTION

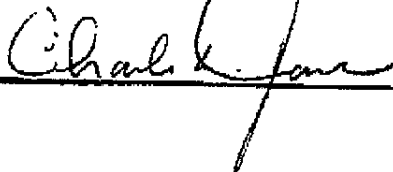

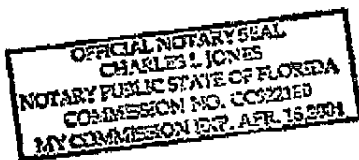
