The undersigned, for the purposes of forming a corporation under the Florida General Corporation act, do hereby adopt the following articles of incorporation:

### **ARTICLE 1**

NAME: The name of the corporation is AMERICAN INSTITUTE OF PARAPSYCHOLOGY, INC.

#### ARTICLE II

PRINCIPLE OFFICE: The principle place of business and mailing address of this corporation shall be: 4131 N.W. Thirteenth Street, Suite 200, Gainesville, Florida, 32609

#### ARTICLE III

PURPOSE: The purpose for which the corporation is organized is:
