### **ARTICLE I. NAME**

### **ARTICLE III. PURPOSE**

The purpose of the **FOUNDATION FOR THE DEVELOPMENT AND WELL-BEING OF THE FAMILY (FUNDABIEN)**, it is to foment the well-being and the socio-economic development of the Honduran family starting from a) the coordination of actions with the Honduran Institute of the Childhood and the Family in the programming and execution of actions for the prevention and integral protection of the childhood and the family, b) the creation of homes and protection centers for children and girls in social risk, c) support to Centers / Homes of special Education that assist special children or with disabilities; in the fields of finances, technical and physical infrastructure in areas such as rehabilitation and development of habits and dexterities, early stimulation, language, gross and fine motor delay, ch) creation and support in the fields of finances, technical and physical infrastructure of home/centers that assists children affected with the Immune Deficiency Syndrome HIV (AIDS), d) financial and physical support to Home/ Centers or refuges that assist women mistreated as a consequence of family violence, and elderly Homes. The **FOUNDATION FOR THE DEVELOPMENT AND WELL-BEING OF THE FAMILY (FUNDABIEN)**, will be able to, for the execution of its end, create in any place of the republic or outside; the centers or institutions referred to in the previous article in agreement with the Constitution and the laws of the Republic, and manage them or to sponsor others, sustained by third parties; and to constitute agents for all or part of the jobs that the **FOUNDATION** develops.


