AMENDMENTS TO ARTICLES OF INCORPORATION FOR WINTER OAKS HOMEOWNERS' ASSOCIATION, INC.

1. Article VII of the Articles of Incorporation is amended as follows:

ARTICLE VII BOARD OF DIRECTORS

The affairs of the Association shall be managed by a Board of three (3) Directors, who need not be members of the Association. The number of Directors may be changed by amendment of the Bylaws of the Association.

2. Article VIII of the Articles of Incorporation is amended as follows:

ARTICLE VIII OFFICERS

The affairs of the Association shall be managed by a President, Vice-President, and Secretary/Treasurer, and such other officers as are permitted in the Bylaws.

The officers shall serve until the organizational meeting of the Board of Directors of the corporation. The officers shall be elected by the Directors at the organizational meeting of the Board of Directors and shall hold office for a one (1) year period from the date of their election.
