**Articles of Incorporation
Of
Crusaders for Christ Church at Sanderson, Incorporated
in Sanderson, Florida**

ARTICLE I – NAME

The name of this corporation shall be: **CRUSADERS FOR CHRIST CHURCH AT SANDERSON, INCORPORATED.**

ARTICLE II – PRINCIPAL OFFICE

The principle place of business and mailing address of this corporation shall be:

ARTICLE III – PURPOSE

This corporation is organized for the following purposes:

1. Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under sections 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States internal revenue law or (b) a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States internal revenue law.
2. Said corporation is organized exclusively for religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of internal revenue code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IV – MANNER OF ELECTION

The membership of this corporation shall constitute all persons herein after named as subscribers, present church members, and such other persons as from time to time the corporation members shall vote to admit.

ARTICLE V – TERM OF EXISTENCE

This corporation shall have perpetual existence.

Any of such assets not so disposed of shall be disposed of by the court having appropriate jurisdiction, exclusively for such purposes or to such organization or organizations, as such court shall determine, which are organized and operated exclusively for such purposes.
