# ARTICLES OF INCORPORATION OF EMERALD COAST CHAPTER OF THE AMERICAN SOCIETY OF TRAINING & DEVELOPMENT, INC. (a not-for-profit corporation)

I, the undersigned, being desirous of forming a non-profit corporation for charitable, professional and philanthropic purposes under the provisions of Chapter 617, Florida Statutes, agree to the following:

#### **ARTICLE I - NAME**

The name of this corporation is: EMERALD COAST CHAPTER OF THE AMERICAN SOCIETY OF TRAINING & DEVELOPMENT, INC.
