ARTICLES OF INCORPORATION

The undersigned, a citizen of the United States, desiring to form a Corporation Not for Profit under the Corporation Not for Profit Law of Florida, Chapter 617, Florida Statutes, certifies and acknowledges:

ARTICLE I: NAME

The name of the Corporation Not for Profit shall be: HUMANE EMERGENCY ANIMAL RESCUE, INC. ("Corporation")

ARTICLE II: DURATION

The duration of the Corporation shall be perpetual.

ARTICLE III: PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is 710 86th Street, Miami Beach, Florida 33141 in Dade County.

ARTICLE IV: PURPOSE

The Corporation is organized exclusively for domestic charitable, educational and scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, as amended, including the following:

- 1. The prevention and amelioration of animal suffering.
- 2. The enforcement of existing laws pertaining to animal welfare.
- 3. To provide education in animal rescue techniques and procedures.

- 4. To formulate, publicize and implement solutions to euthanasia of homeless pets.
- 5. To provide animal related disaster relief.
- 6. To offer assistance in transport, treating and housing animals in need.
- 7. To make donations or distributions to other not for profit organizations within the meaning of section 501(c)(3).

Article V: MEMBERS

The qualification for members and the manner of their admission shall be as stated in the bylaws of the Corporation.

Article IV: POWERS

The powers of the Corporation shall be as provided in Chapter 617, Florida Statutes with the following limitations within the meaning of section 501(c)(3) of the Internal Revenue Code, as may be amended:

A. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV.

- B. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the Corporation shall not participate or intervene in, including the publishing or distributing of statements, any political campaign on behalf of or in opposition to any candidate for public office.
- C. Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

ARTICLE VII: REGISTERED AGENT AND OFFICE.
