**Articles of Incorporation
Of**

Complete Soccer Academy – Florida, Inc.

Article I

The name of the corporation shall be: Complete Soccer Academy- Florida, Inc.

Article II

The principal place of business and mailing address of this corporation shall be:
8 Edgewood Way, Ormond Beach, FL 32174.

Article III

The purpose for which the corporation is organized is:

This corporation is organized and operated as an educational, and sport corporation under Florida Statutes, Chapter 617, et, seq., and under Section 501 (c) (3) of the Internal Revenue Code for the purposes of:

- a. To train young athletes in the game of soccer
- b. To educate young athletes in soccer methodologies
- c. To prepare young athletes for Olympic Development trials
- d. To train, educate and prepare young athletes for college soccer
- e. To provide an environment that will accommodate competitive athletes engaging in other activities allowed for not for profit, tax-exempt organizations under the laws of Florida and the Internal Revenue Code, provided such activities are consistent with the purposes stated above.

No part of the Corporation's net profit shall be distributed to its members, directors or officers. Any excess of revenue over expenses shall be solely to the pursuit of the not for profit educational, sporting, tax exempt purpose of the Corporation.

Article IV

The manner in which the directors are elected or appointed:

The incorporators will appoint the initial directors. Thereafter, the directors then sitting shall elect them.

Article V

The number of Directors constituting the first Board of Directors is three. The names and addresses being as follows:

Article VI

All powers of the Corporation shall be exercised by the members, if any, and/or Directors as set forth in the By-laws.



No part of such assets shall be distributed to the Corporation's members, directors or officers.


