Article I

The name of the corporation shall be **TAVERNIER YOUTH FOOTBALL LEAGUE, INCORPORATED.**

Article II

The principal place of business and mailing address of the corporation shall be: **POST OFFICE BOX 571, TAVERNIER, FLORIDA 33070.**

Article III

The purpose for which the corporation is organized is **TO PROMOTE AND SPONSOR A FOOTBALL LEAGUE FOR YOUNG PEOPLE IN THE UPPER FLORIDA KEYS.**

Article IV

The manner in which the directors are elected or appointed shall be **BY PLURALITY VOTING OF THE COMMON STOCK TO TWO-YEAR TERMS, STAGGERED AS EVENLY AS POSSIBLE WITH VACANCIES BEING FILLED BY SPECIAL ELECTION WITHIN THREE (3) MONTHS OF THE VACANCY.**


