## ARTICLE I NAME

The name of the corporation shall be:

MAHADHATUJETIYARAM TEMPLE INC.

(Thai Buddhist Temple in West Palm Beach of Florida) That is a non-profit religious corporation.

WE, the undersigned, do hereby associate ourselves together for the purpose of forming a corporation not for profit under the laws of the State of Florida, and do hereby certify as follows:

## ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address shall be:

## ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- 1) Be a temple of worship for all Buddhists and a place of obtainment of merit and performance of ceremonies.
- 2) Be a sanctuary of tranquility and living Buddhist Philosophy for all that need it.
- 3) Be a monastery where monks live, perform traditional rites and practice the teachings of Buddha
- 4) Be a retreat for meditation and a place of guidance for those who seek peace of mind.
- 5) Be a center for promotion, the studying South East Asian cultures and a meeting place of various people's where international understanding is built.
- 6) Be a place to introduce and support those who wish to chant and meditate.
- 7) To be a monument for South East Asian culture and living Buddhism for all to enjoy.
- 8) To be a "Town Hall" for the Thai people of West Palm Beach.
- 9) To be a museum for the introduction to and the understanding South East Asia, it's people customs, beliefs, and way of thinking, cuisine and material culture.

## ARTICLE IV MANNER OF ELECTION

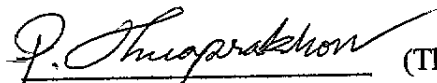

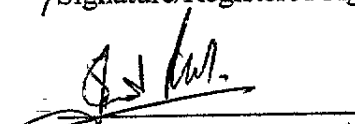

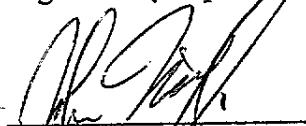
