# ARTICLES OF INCORPORATION An Florida Nonprofit Incorporation

The Undersigned, majorities of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

ARTICLE I - Name of Corporation NU-VISIOIN OUTREACH MINISTRIES, INCORPORATED

The name of the Corporation shall be: Nu-Vision Outreach Ministries, Incorporation and its affiliates, Nu-Vision Fellowship Center, Nu-Beginning Transition Center for Battered Women and Women with Children, Nu-Outlook on Life Rehabilitation Center and Nu-Vision Children Learning Center.

## **ARTICLE II** - Location of Principal Office

The place in this state where the principal office of the Incorporation shall be located 2518 North "T" Street, Escambia County, Pensacola, Florida 32501.

## ARTICLE III - Purpose
