ARTICLE 1 NAME

ARTICLE 11 PRINCIPAL OFFICE

ARTICLE III PURPOSE

ARTICLE VIII Organization Dissolution previsions

Section 1

Once the organization has been dissolved and no longer function as it intended purpose all remaining assets must be used for only charitable religious purposes.

Section II

Upon the dissolution of The Epps Christian Center Ministry, Inc. the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the ministry shall dispose of all the assets of the Ministry exclusively for the purposes of the Ministry in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501©(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.
