Thank you for your November 14<sup>th</sup> response to our plea for assistance in renewing our Bridgewater Master POA.

This year it may have been our lack of understanding to check the appropriate box "not applicable" on the renewal form which has been done on this re-submittal.

When the 1<sup>st</sup> return was sent back to us mid July, it indicated we needed to obtain a FEI number and send it back to the Division of Corporations. I'll try and give you the short version of our aborted attempts to get a FEI;

- First I tried to use the number given by your (850) 245-6056 to contact the federal office which resulted in nearly an hour going through the number punching to then be advised it was most easily done online.
- I was able to download the SS-4 forms and attempted to fill out everything applicable but received no confirmation.
- Called back the federal office (800) 829-1040 and spent another ½ hour before finally getting a real live person on the line.
- Repeated the reason and results to then be advised to review "Do I need an EIN?" as the
  representative noted there was no reason to have an EIN with no past, present of future
  employees, vendors, etc.
- I then wrote the November 7<sup>th</sup> letter that ended up in your hands.

As you are aware, we were unable to get an EIN number based on the conditions and responses on the "Do I need an EIN?" which I have attached a copy for your review. It appears that we do not qualify as needing an EIN. This is good news as I would hate to go all through this again.

We really appreciate your generous assistance in the matter and look forward to having our Master POA re-instated. The only function for the Bridgewater Master POA is to respond to various land management and zoning requests going to Orange County to ensure compliance with the Bridgewater Master Plan which surrounds our Lake Cawood Estates, POA along with a handful of other POA's. Thanks you again.
