The undersigned, acting as incorporator(s) of a corporation in compliance with Chapter 617, Florida Statutes, (Not for Profit) adopt(s) the following Articles of Incorporation

ARTICLE I: NAME

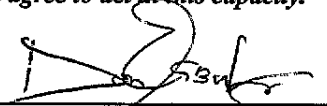
