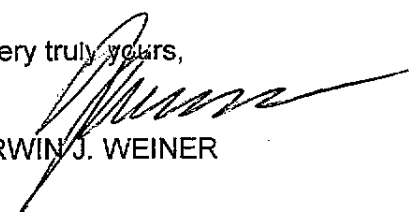

ARTICLES OF INCORPORATION (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

National Association of Two-Year-Old Consignors, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

1. To promote the integrity of the sale of two-year-old Thoroughbred horses at public auction.
2. To promote and improve the exchange of ideas within the Thoroughbred industry in general and specifically between companies conducting public auctions of Thoroughbred Two-Year-Olds in Training, consignors to those auctions and potential buyers at those auctions.
3. To promote methods of training and providing for the general care of Thoroughbred horses in order to maximize their health and well-being.
4. To educate and inform the general public about the purchasing of Two-Year-Old Thoroughbreds offered for sale at public auction.
5. To promote co-operation between companies conducting auctions of Two-Year-Old Thoroughbreds and consignors to those auctions to formulate plans and procedures for testing of horses entered in the sales and engaging in pre-sale workouts in order to protect both the health of the horses and to ensure that purchasers can evaluate the true potential of horses offered for sale.

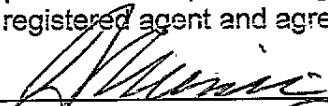

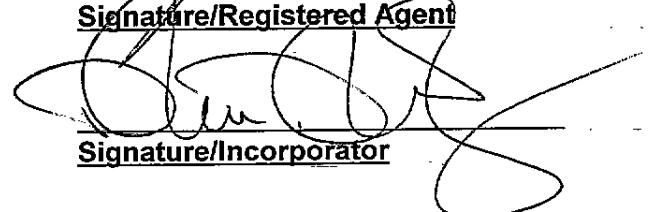
