ARTICLES OF INCORPORATION FOR CLAY COUNTY SHERIFF'S OFFICE HUMANITARIAN FUND, INC.

The undersigned, acting as incorporator for the purpose of forming a corporation not-forprofit under the laws of the State of Florida hereby adopt Articles of Incorporation, as follows:

ARTICLE I - NAME

The name of the corporation shall be:

Clay County Sheriff's Office Humanitarian Fund, Inc.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be:

901 North Orange Avenue Post Office Box 548 Green Cove Springs, Florida 32043

ARTICLE III - PURPOSE

The specific purpose for which the corporation is organized is:

Organized primarily for providing recognition, appreciation, and benevolence to employees and families of the Clay County Sheriff's Office and may assist in funding of office social events that includes all employees and families of the Clay County Sheriff's Office.

Funding of this corporation will come exclusively from volunteer donations from the employees of the Clay County Sheriff's Office, from private sector donations and from fund raising activities. No activities of this corporation will be conducted which would reflect unfavorably on the Sheriff's Office.

No part of the net earnings of the corporation shall be inured to benefit or to be paid to its members, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles. No part of the activities of the corporation shall be carried on for propaganda, or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Upon the dissolution of the corporation, its assets shall be distributed to the Clay County government for public purpose.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

The corporation shall consist of seven (7) directors, with (2) from each Division (Administration, Corrections and Operations) and (1) at large that is recommend by the Divisions Directors and approved by the Sheriff. The number of directors may be increased or diminished from time to time by by-laws adopted by the Board of Directors, but shall never be less than seven (7). Directors shall be appointed from the employees of the Sheriff's Office in accordance with the by-laws.
