

- 1. Article IV, PURPOSE AND POWERS OF THE ASSOCIATION, Section D of the Articles of Incorporation, shall be amended to read as follows:
 - d. To own, maintain, repair and operate the property of the Association as appropriate, specifically but without limitations the Surface Water Management System in the manner described on Exhibit. "C" to the Declaration; ...

THE REMAINING PORTION OF THIS SECTION REMAINS UNCHANGED

2. ARTICLE VI, VOTING RIGHTS, of the Article of Incorporation, shall be amended to read as follows:

The Association shall have one class of voting membership:

Class A. Class A members shall be all Owners, with the exception of the Declarant, and who shall be entitled to one vote for each Lot owned. When more than one person holds an interest in any Lot, all such persons shall be members. The vote for such Lot shall be exercised as they determine pursuant to provisions for voting in the Bylaws, but in no event shall more than one vote be east with respect to any Lot.

Class B. — Class B members shall be the Developer and any successor of Developer to whom Developer has assigned its rights hereunder. The Class "B" members shall originally be entitled to thirty (30) votes; this number shall be decreased by one (1) vote for each Class A Member existing at any one time. The Class B membership shall terminate and become converted to Class "A" membership upon the happening of the earlier of the following:
